### From the Editor's Desk

big welcome to all our new members from Smithtown's 2015 retirees. We are certainly glad to welcome you into the fold. The SSRA (Smithtown Schools Retirees' Associ-

ation) was established a little more than 20 Common Core testing. Yet, somehow, these years ago to assist our retirees in making the transition into retirement as simple and enjoyable as it should be. Through the SSRA we try to keep you in touch with former colleagues, make you aware of any legislation affecting your retirement, as well as, keep you apprised of any changes in benefits that occur once you are retired.

An example of this is a vision plan for you and your family only available to retirees. Details of this plan can be found on page 8. It is an annual plan with no permanent obligation.

As 2015 retirees, you are complimentary members of the SSRA for the remainder of this calendar year. We operate on a calendar year in conjunction with the other retiree districts in RC #23.

It appears that the 30,000 emails sent to the Regents has generated some rethinking on their part. In a split vote, the Regents has approved a 30 day delay to overhaul the flaws in the APPR (Annual Professional Performance Reviews) regulations. The Regents acknowledged the claims by educators and parents that the current system of testing and evaluations in conjunction with the Common Core does indeed contain many flaws. Consider this....testing is done only in Math and English//Language Arts. Yet, somehow all

teachers are evaluated based on these scores, in subjects they do not teach and by students they may not even know. In NY last year, more than 200,000 students opted out of the

scores are still considered valid for evaluation.

Albert Einstein once commented, "Everybody is a genius. But if you judge a fish by its ability to climb a tree, it will live its whole life thinking it is stupid," Is this going to happen to children today because of its emphasis on test scores?

Much has or will happen for our Smithtown retirees. Our SSRA (STA) office has recently moved to its new location at 26 New York Avenue. Our newly developed website is now up and running with a much easier means of accessing it. Our annual Fall luncheon at St. George's Golf and Country Club will be held on October 14th. ### New Website Up and Running



A three day land tour took us to Denali (Mt. McKinley). It is rare that you can see the top of the mountain and unfortunately, this was the only overcast day we had. There is no argument in Alaska over what is the tallest peak in North America. It was "Denali" wherever we went. There is so much more to see in Alaska. I am sure I will visit again, perhaps later in the season, to see the salmon run, the wildflowers, and other natural wonders of this vast and beautiful state.


So yes, retirement is a good thing, a very good thing. 99% attitude, 1% \*\*\*\* happens! .

### NYSUT Members Hold Protest At Sagamore Resort

Last month, Campbell Brown, former CNN anchorwoman, and a proponent of charter schools and anti-tenure laws spoke at a meeting of the New York State Business Council. The meeting was held at the Sagamore Resort in Lake George. NYSUT leaders and supporters protested outside with signs and received quite a bit of news coverage.

Campbell Brown has long been a spokesperson for wealthy hedge fund managers who would like to privatize and benefit from public education.

Brown has officially launched an online news site known as the "The Seventy Four." The name comes from the 74 million children under age 18 in the U.S. Its agenda is to challenge the educational establishment by promoting anti-union and anti-tenure legislation.

Campbell founded the Parents' Transparency Project known as PTP, based in NY City. The organization is, as mentioned before, a strong supporter of charter schools and wishes to change the current tenure laws. Campbell refuses to disclose the names of the billionaire funders for her organization claiming their right to privacy.
